Whereas, Development Plans of K(E), H(E) "L" Ward & "M" Ward of Greater Mumbai (hereinafter referred to as "the said Plans") have been sanctioned by the Government in Urban Development Department's Notifications dated 12/11/1992, 8/5/1992, 17/5/1992 & 8/5/1992 respectively and to came into force with effect from 29/12/1992, 17/5/1992, 2/5/1992 & 17/5/1992 respectively under section 31 of the Maharashtra Regional and Town Planning Act, 1966 (hereinafter referred to as "the said Act");

And whereas, the development of the Airport poses special problems. The planning and development of the Airport has to be so carried out that the potential of the land is utilised to the fullest extent possible, so as to achieve, in a precise manner, the technical and aeronautical requirements on the one side and the competitive edge of the Airport vis-à-vis other airports within and outside the country on the other;

And whereas, the limited area available for the Mumbai Airport, its location, almost in the middle of the Metropolis and its land-locked situation surrounded by slums create challenges in its planning from the perspective of infrastructural development, safety and security of the Airport and its users;

Now therefore in exercise powers conferred by sub-section (1)(C) of section 40 of the said Act and all the powers enabling it in this behalf the Govt. of Maharashtra hereby appoints "Mumbai Metropolitan Regional Development Authority (MMRDA)" as the Special Planning Authority for the area bounded by the Airport boundary, specifically shown on the plan attached herewith subject to following conditions -

1. An FSI of 1 will be available for development of the area for which MMRDA is appointed as SPA.
2. Mumbai International Airport Pvt. Ltd., (MIAL) on behalf of the Airport Authority of India may utilise the available FSI for the entire area, anywhere in the area (Global FSI), after deducting utilised FSI. The utilised FSI will include FSI consumed by slums, leased premises, developments on gotham lands, and any other structure existing on the airport land.
