Mumbai Metropolitan Region Development Authority (MMRDA) desires to undertake erection of State-of-the-art Street Furniture in E, G & G-N blocks of Bandra-Kurla Complex (BKC) and hereby invites bids on Design, Build, Operate, Maintain and Transfer (DBOMT) basis, against the advertisement rights thereon for concession period of 15 years.

<u>Scope of work:</u> The scope of work shall include Design, Build, Operate, Maintain and Transfer to MMRDA Street Furniture items like Benches, Litter bins, Information Boards, Direction Boards, Multipurpose Booths, Flag poles, Vending kiosks, Public Convenience, Bollards, Pole mounted CIP, Bus Queue Shelters, Tree Guards, Bicycle stands and Bicycles of International Standard as detailed in the Bid Document.

Eligibility Criteria:

- i. The agency must be eligible and competent to enter into contract under the 'Indian Contract Act 1872' and shall have office in Mumbai.
- ii. The agency shall have experience of Designing, Building, Operating and Maintaining minimum 50 % of each of the quantities of any of the 6 types of street furniture items, mentioned in the bid document within a city within a year in last 3 years.
- iii. Minimum 3 years of experience in the field of Outdoor Advertising on the above mentioned Street Furniture items is essential.
- iv. The minimum Annual turnover of the agency shall be Rs. 50 Crores for each of the last 3 years with minimum 25% turnover in fields of erection of street furniture and advertisement on Street Furniture.
- v. The agency shall submit valid solvency Certificate of Rs. 10 Crores from any nationalized or Scheduled Fank preferably in Mumbai.

CHAPTER – 1

INSTRUCTIONS TO BIDDERS

ERECTION OF STREET FURNITURE IN BANDRA-KURLA COMPLEX ON DESIGN, BUILD, OPERATE, MAINTAIN & TRANSFER (DBMOT) BASIS

- 1. **Bandra-Kurla Complex (BKC):** Mumbai Metropolitan Region Development Authority (MMRDA) is the Special Planning Authority (SPA) for Planning and Development of Bandra-Kurla Complex comprising of E, G, and GN blocks; spread over 360 ha. in Bandra (East) of Mumbai. BKC is being developed as 'International Finance and Business Centre' (IFBC) of world standards and several prestigious Corporate Offices and Nationalized Banks are presently functioning from BKC. The Complex has State-of-the-art infrastructure. The Complex when fully operational shall have about 2 Lakhs jobs.
- 2. The Bid herein called by Mumbai Metropolitan Region Development Authority (MMRDA) is for Erection of Street Furniture Items in 'E', 'G', and 'GN' Blocks of Bandra-Kurla Complex, Mumbai on Design-Build-Operate-Maintain and Transfer (DBOMT) basis; as stipulated in the list enclosed and at the locations as shown in drawings enclosed with this bid subject on the conditions mentioned below and further subject to the 'Contract' annexed hereto. 'Instructions to Bidders', Form of Bid, 'Conditions of Contract,' 'Form of Financial Offer' and Annexuse A' to 'E' are enclosed. You are requested to fill the bid and return the part in original to MMRDA duly signed on each page and certified, with the Earnest Money in the form of pay order/DD in favour of 'MMRD Fund' on or before the closing date.
- 3. The bidder shall read and understand all the terms and conditions before submitting the bid. All the work is to be carried out in accordance with this 'Bid Document' and as approved by OIC (Officer in Charge).
- 4. The Authority reserves the right to reject any or all the bids without assigning any reason thereof.
- 5. The Security Deposit shall be deposited as stipulated in 'Conditions of Contract'.
- 6. No alterations shall be made by the bidder in the contract, and if so made, his bid will be disqualified. The conditional bids shall be rejected. Any other information regarding the contract can be obtained from the OIC at the above address on any working day during the office hours.

- 7. The successful bidder has to erect Street Furniture items at his cost on specified locations or as approved by Officer In-charge (OIC) and offer Lump-Sum charges to be paid to MMRDA for concession period against the advertisement rights offered to bidder under this contract. Responsive bids shall be evaluated as mentioned in item 22 and 23.
- 8. If a claim for non-payment or underpayment of ESI Contribution (Employees' and Employer's) in respect of labour employed by the bidder is made by the ESI Corporation on the Authority, then it will be the Bidder's liability to make payment and indemnify the Authority and the Authority will be at the liberty to withhold any amount due to the bidder until it is satisfied that all amounts due under the ESI act are paid.
- 9. The Bidders are requested to inspect the spots of Erection of Street Furniture items mentioned in the Annexure 'A' and shown in the Annexure 'E' before bid. The Authority shall submitting the not be responsible hindrance/obstruction, if any, to the display of the advertisement thereon or its non display due to any reason whatsoever beyond the control of the Authority once the contract is awarded. The number of Street Furniture items given in the Annexure 'A' may vary depending upon prohibition, if any, for displaying advertisement thereon by a competent statutory authority or any other reason. For such cases, item 16(c) of 'Cooditions of Contract' shall apply.

10. Bidder's Office and other retails

- i. The Bidder shall have its office in Mumbai and shall be required to operate the contract from Mumbai.
- ii. The Bidder should mention the name and address of the proprietor of the company. In case of partnership firm, name and address of the respective partners and in case of limited company, name and address of the Managing Director with supporting documents such as Memorandum and Articles of Association under the Companies Act and latest Annual Report of the company shall be provided.

11. Financial Offer

- i. Financial offer must be submitted in 'Form of Financial Offer' failing which the offers are liable to be rejected.
- ii. The financial offer amount should be in figures as well as in words preferably type written.

- iii. In case of divergence between offers in figures and words, the Offer given in words will be taken as correct amount.
- iv. All pages and all corrections made in the bid must be initiated by the bidder.

12. Signature of bidder

The 'Form of Bid' as in Chapter '2' and 'Form of Financial Offer' as in Chapter '4' must be dated and signed on each page by the Bidder. Any BID not so signed is liable to be rejected. The signature of the Bidder on the form of bid shall be construed as an acknowledgement on his part that he has acquired all the information in order to quote his financial offer.

The signature of the Bidder (who is later declared as successful) on the 'Form of Bid' shall also be construed as if the Bidder has entered into a binding agreement with the Authority on the terms and conditions stated in the form of bid till he signs the contract/agreement documents and he shall abide by all the conditions of contract.

13. Commencement and Concession period

Date of commencement of contract shall be mentioned in the Work Order to the Contractor hereinafter known as the Agency and the period of concession shall be 15 years from date of work order.

Depending upon the performance of the Agency, MMRDA reserves the right at its sole discretion to extend the contract by such period, not exceeding 5 years, on the same terms and conditions mentioned in this bid.

14. Earnest Money

- i. Every BID must be accompanied by Earnest Money Deposit of Rs. 50 Lakhs (Rupees Fifty Lakhs only) to be paid by Demand Draft / Pay Order drawn in favour of the "MMRD FUND" and payable at a Schedule Bank in Mumbai.
- ii. The Bidder should mention the receipt number and the date in the column provided for this purpose in the 'Form of financial Offer'.
- iii. No bid will be considered unless the Earnest Money is paid along with the bid.
- iv. No interest will be payable on this Earnest Money Deposit.
- v. The Earnest Money deposited by the unsuccessful Bidders will be **refunded** only after the expiry of the validity period of the bid i.e. 180 days after opening of financial offer.

vi. The Earnest Money will be forfeited

- a. If the bid is withdrawn after the closing and before the expiry of the last date of the period of validity mentioned in bid.
- b. If the successful Bidder fails to deposit the Security Deposit as mentioned in the 'Conditions of Contract'.
- c. If it should at any time be discovered that the Bidder has submitted more than one bid under different names, all his bids will be rejected or agreement cancelled and Earnest Money and/or Security Deposit forfeited.
- d. Any attempt made to influence anyone for the award of contract will disqualify the Bidders.

15. Acceptance of bid

The right of acceptance of bid will rest with the Competent Authority of MMRDA, which does not bind itself to accept the bid with highest composite score or any bid and reserves to itself the authority to accept, amend, modify, negotiate and/or to reject at any time any all the bids received at it's sole discretion without giving any reasons thereof and without any cost to MMRDA.

16. Eligibility Criteria of the bidders

The acceptance of the bid shall be governed by the 'Conditions of Contract' hereto attached. The Bidder shall submit the documents to MMRDA satisfying the following minimum elimibility criteria. <u>Joint Ventures are not allowed</u>,

- i. The bidder must be eligible and competent to enter into contract under the Indian Contract Act, 1872 and shall have office in Mumbai. Outstation agencies shall be eligible for participation in the bid if they agree to open there office in Mumbai if the bid is awarded to them.
- ii. The bidder shall have experience of Design, Build, Operate and Maintaining minimum 50% of each of the quantities of any of the 6 types of street furniture items, mentioned in Annexure A; within a city within a year in last 3 years.
- iii. The bidder shall have Minimum 3 years of experience in the field of Outdoor Advertising on Street Furniture items mentioned in Annexure A is essential.
- iv. The bidder shall have the minimum Annual turnover of Rs. 50 Crores for each of the last 3 years with minimum 25% turnover in fields of erection of street furniture and advertisement on Street Furniture.

v. The bidder shall submit valid Solvency Certificate of Rs. 10 Crores from any nationalised or Scheduled Bank preferably in Mumbai.

17. Validity

The offers submitted shall remain valid for acceptance for a period of **180 days** from the date of opening of the Financial Offer.

18. Addenda/Corrigenda to the bid document and Minutes of the Pre-Bid Meeting, if issued by MMRDA shall be part of a bid document and it shall be signed, initialled and submitted by the Bidder along with bid document.

19. Submission of Bids

The bidder shall provide self certified copies of all the documents as prescribed in item 16. Those bidders not submitting the required information and documents as specified in item 16 are liable for rejection and shall be treated as non responsive. Also, Bidder shall submit its concept, theme, design, drawings and specifications (material, size, shape, make, fixing details, etc.) of street furniture items to be proposed; specified in Annexure for advt. display (if any) not exceeding overall advt. area as specified in Annexure 'D' as a part of Technical proposal. Further to the bidder shall provide implementation, operation and maintenance plants be adopted for the project.

- Envelope 'A' i.e. Technical Proposal shall contain Earnest money, documents justifying Eligibility criteria and detailed design information as mentioned above and shall be opened first.
- Envelope 'B' i.e. Financial offer shall be opened only of those bidders who qualify in Technical proposal.
- Envelope 'C' containing both the envelopes (Envelope 'A' with Technical Proposal and Envelope 'B' with Financial Offer) shall be submitted to the MMRDA; sealed and duly superscribed with the words "Bid for Erection of Street Furniture in Bandra-Kurla Complex, Mumbai on DBMOT basis" and addressed to the Joint Project Director (Town Planning), Mumbai Metropolitan Region Development Authority (MMRDA), 2nd Floor, Bandra-Kurla Complex, Bandra (East), Mumbai 400 051.

20. Last date of Submission

Bids shall be deposited in the sealed Bid Box in office of the Joint Project Director (Town Planning) at the address mentioned above latest by 3.00PM on 31st July 2013.

Bids received after the aforesaid hours and date shall be rejected.

Bids shall not be sent/ received by Post/Courier etc. Bids shall be accepted in person only.

21. Opening of Bids

Bids shall be opened, if possible, at 04.00 p.m. on the same date i.e. 31st July 2013 at the office of the Joint Project Director (Town Planning), 2nd Floor, Bandra-Kurla Complex, Bandra (East), Mumbai or at any other location as decided by MMRDA in the presence of such bidders who may desire to be present.

A bid not in compliance with the aforesaid conditions is liable to be rejected.

22. Selection of Preferred Bidder

i. Stage I: Evaluation of Technical proposal :

- a. EMD: As per the criteria set out n tem 14 of 'Instructions to Bidders'.
- b. Eligibility Criteria: As per the criteria set out in item 16 of 'Instructions to Bidders'.
- c. Documents for Design Information: As per the evaluation parameters mentioned in item 23 (i).
- d. Those bidders who secure Technical Score of 70 and above shall qualify for evaluation of financial bid.

ii. Stage II: Evaluation of Financial Offer:

Qualified bidders in Stage I shall be evaluated on the basis of the evaluation criteria as mentioned in item 23 (ii).

- iii. Stage III: The composite evaluation of the Technical proposal and the Financial Offer would be carried out as set out in item 23 (iii).
- iv. Stage IV: The bidder securing highest composite score shall be successful bidder. However, MMRDA reserves the right to accept or reject the proposal of the Bidder with highest composite score.

CHAPTER – 3

CONDITIONS OF CONTRACT

ERECTION OF STREET FURNITURE IN BANDRA-KURLA COMPLEX ON DESIGN, BUILD, OPERATE, MAINTAIN & TRANSFER (DBMOT) BASIS

1. Scope of Contract

- This contract is for erection of Street Furniture items in Bandra-Kurla Complex on Design-Build-Operate-Maintain-Transfer basis; as per the quantities mentioned in Annexure A, specifications mentioned in Annexure D and at locations mentioned in Annexure E of this bid or as approved d by OIC against the display of advertisement on Street Furniture items mentioned in the design and drawing of Street Furniture items and subject to approvals of all statutory authorities after due payment to all such authorities. It also includes paying the authority a sum of display charges as per the 'Form of Financial Offer'. The Construction Period of Street Exhiture items shall be 365 days and in phases from the date of Work Order. Phase -I (construction period before 180 days) shall indiude entire E block and 45 m road in G block. Phase -II (construction period before 270 days) shall include balance roads in G block. Phase -III (construction period before 365 days) shall include - n Block. However, the bidder is at liberty to complete Phase I and III along with Phase I and or before 180 days for which he will receive bonus as mentioned below.
- b. The designs, specifications and locations provided by MMRDA are only for indicative purpose only. This shall act as minimum bench mark. The bidder shall propose innovative, aesthetic state of the art designs which are environment friendly, structurally safe, durable for at least 20 years, rust proof and which gel with the overall urban built form of BKC. However, the maximum total advertisement display area shall remain unchanged. The bidder also has liberty to propose advertisement on any other items subject to total maximum advertising area remaining unchanged and subject to approval by MMRDA.
- c. The concession period shall be for 15 years including the construction period. The probable date of Work Order shall be 01st October 2013. MMRDA reserves the right to extent the concession period by another 5 years on the same terms and conditions.

b. Bonus V/s Penalty

For completion of entire construction of all the street furniture items before end of 365 days the display will be allowed from the date of completion and no premium fees for this pre-completion period will have to be paid to Authority and will act as bonus to the Bidder. However, display shall be allowed after satisfactory completion of all Street Furniture items, and after obtaining Completion and Electricity Certificate from PWD/ Certificate from certified Electrical Engineer, submitting Structural Stability Certificate to MMRDA and compliance of all statutory approvals. If the bidder exceeds the construction period, than the premium shall be payable by the bidder from the 365th day irrespective of the advertisement display and erection of street furniture. However the genuine delay beyond the control of bidder can be condoned by MMRDA if duly justified by the bidder. However the decision of MMRDA shall be final and binding.

The Agency, may, as per the design, proposed by him, display the advertisement of any product/company of the Street Furniture item; as per the specifications mentioned in Annex or D and not exceeding the overall advt. area as specified. While subnitting the drawings for approval to the OIC, the Agency shall clearly mark the proposed space for advertising. After approval from the OIC, the Agency shall also take prior approval from other Concerned Authorities as may be required. The bidder shall submit dimension drawing (parh), plan, section, elevation, 3 D perspective, colour drawing, with specifications, material, advertisement area, etc on A4/ A3 size paper.

The Agency shall not be allowed to display advertisement on Street Furniture items unless and until the Security Deposit referred to in Clause No. 18 of 'Conditions of Contract' is paid to the Authority vis-à-vis before obtaining the necessary permissions/NOC from the MCGM or other concerned statutory authorities and after paying the necessary charges to the concerned authorities.

c. The Agency shall obtain approvals from all the statutory authorities concerned necessary for display of advertisement on Street Furniture Items and its illumination. The Agency shall submit such approvals / NOC's to the OIC. All the charges for obtaining approval / NOC's from statutory authorities shall be borne by the Agency.

d. The successful Bidder is bound by the terms and conditions of this contract, to display advertisement on Street Furniture Items mentioned in the Annexure 'A' and Annexure 'E'

e. Financial Offer

The Bidder has to offer Lump sum premium fees/display charges to be payable to MMRDA for the concession period in form of financial offer against the advertisement rights offered to him under this contract. The entire amount quoted shall be divided into equal monthly installments to be paid in advance of each month. (Please refer clause no. 16 of 'Conditions of Contract'.)

g. The Agency shall not be permitted to carry out any addition / alteration in the locations/specifications of Street Furniture Items once approved in the contract. However, the Agency may propose an alternative location/specification better than that given in the bid documents (specifications, materials and improved facilities for pedestrians) for any or all of the Street Furniture Items, if so desired, for evaluation to the Design Committee/ MMRDA. MMRDA reserves the right to accept such change proposed to bidder without change in overall Advt. area of the project. No claim for compensation of whatsoever nature including reduction in display charges will allowed against reduced display areas, if any. The newly constructed Street Furniture items shall be the property of this Authority and will be handed over to MMRDA after end of concession period and in proper functional order.

2. Removal/shifting of Street Furniture Items and advertisements on them

- a. The Agency shall alone be responsible for the display of advertisement on Authority's Street Furniture Items. The Agency shall submit complete details of the framework proposed for advertisement for the perusal of OIC. The Agency shall comply with the directions / instructions of the OIC in respect of the said arrangement. The Agency shall also comply with the directions / instructions of the representative of Joint Project Director (Town Planning), owner's Representative of the project if and when deputed to the site for supervision.
 - b. The Agency should attend the complaints pertaining to the Street Furniture and the advertisement provided on them within 3 days from the receipt of such letter issued by OIC from time to time. All expenses connected with such complaints including removal/shifting of Street Furniture items or advertisements; maintenance of Advertisements etc, if any, shall be borne by the Agency.

If at any time during the continuance of the contract, any Authority duly empowered or authorised in that behalf by OIC requests for any reason including road widening, concreting/ Public utility shifting/ repair etc. to remove the Street Furniture items or advertisement on Street furniture items, the Agency on prior intimation from the Authority shall remove such item and/or the advertisement displayed on it at their own expense forthwith. If the Agency shall make default in such removal after notice to that effect has been served upon them by the OIC within the time period stipulated in the notice, then the OIC shall be at liberty to effect such removal at the risk and cost of the Agency without the Agency becoming entitled to any compensation in respect thereof and in that case clause no. 13 shall apply. In addition to this the Agency shall be liable to pay the penalty/charges equal to Rs. 10,000/- (minimum) per Street Furniture item. The Agency shall be entitled to take back the said material from the Authority within a period of 15 days from the date of intimation to the Agency to that effect after which such materials would become the property of the Authority and the Agency shall have no claim of whatsoever nature on them.

3. Erection & Maintenance of Advertisement

The Agency shall maintain the Street Furniture items' illumination on and public facilities in a proper and usable manner in accordance with technical specifications. The ency shall bear all costs incurred for display of advertisement on Street Furniture items and shall carry out the work of fixing and removing the same in a careful manner without doing any damage to the Street Furniture items and the adjoining property. If any damage is caused to the same, it shall be made good by the Agency at its own cost to the entire satisfaction of the OIC. The Agency shall maintain the advertisement along with the framework, if any, in good condition and likewise ensure that the display of advertisement thereon is in a proper and perfect condition. The Agency shall immediately on receiving notice from the OIC make good at their own expense the default / fault in the Street Furniture item/ advertisement with the structure to the entire satisfaction of the OIC within seven days from the date of receipt of such notice, failing which the Authority shall be at liberty to proceed with the work required to be carried out at the risk and cost of the Agency without any further notice to them as stipulated in Clause No. 13 appears herein after.

- b. While the Street Furniture items or advertisements are being fixed or removed or re-fixed by the Agency, it shall take all necessary safety precautions and if any damage is caused to or is suffered by a person or property of the Authority or by any third party due to any cause whatsoever, the Agency shall be solely responsible for compensation or damage to the Authority's property or the third party as the case may be and the Agency shall indemnify and keep the Authority indemnified in respect of any claim made thereunder.
- c. MMRDA shall not be liable to pay any compensation in case the Agency, their servants, agents or any other person meet with an accident or in case any injury is caused to or suffered by any one of them or by any third party or to any property whatsoever while the work under the contract is undertaken by the Agency. The Agency shall keep the Authority indemnified in that respect. The agency shall be responsible for structural safety of the Street Furniture items and indemnify MMRDA for any damages. The agency shall cover the street furniture items under insurance policy as specified in item 46.
- d. The Agency shall not carry out any addition or alteration to the any of the Street Furniture items unless; it approved by the OIC.

4. Illuminated Advertisement

The Agency shall be permitted, subject to power cut and / or any other restrictions and / or other rules in force, which are beyond the control of the Authority to display illuminated advertisement on those Street Furniture items that are mentioned in the Annexure 'D' and 'E'. However, due to nonavailability of power supply for any reason, no claim of any sort would be entertained in this regard. No separate payment will be charged from the Agency for illuminating the advertisement. The installation work including electrification should be done by the Agency. The structure / design should have prior approval of the OIC the electricity bills for such illumination should be paid by the Agency directly to the concerned authorities. The electrical installation including earthing of all metallic parts, provision of ELCB etc. shall be in accordance with the provisions of the Indian Electricity Act, 1910 and Indian Electricity Rules and the approved plan. All external and internal wiring cables, fittings including service cables and provision of Meter Box, etc. required for illumination of Street Furniture Items/advertisements shall be procured and laid by the Agency at its own

cost using the ISI approved materials and as per Standard Specifications. The Agency shall provide/ install the electric meter box at appropriate height, so that it should not obstruct the commuters/ pedestrians. No additions or alterations should be made without prior approval of the Authority. The illuminated advertisement to be constructed/put up should be completely waterproof, so that no water enters inside and damages electrical wires, etc.

The Agency shall protect the electric installation and shall arrange to maintain it in good and safe working condition by way of periodical checking (at least every 3 months) and renew it as and when necessary with the approval of the Statutory Authorities concerned as the case may be. The bidder shall obtain Electricity safety Certificate for all installed Street Furniture items with Electricity from PWD/Certified Electrical Engineer every year and submit to MMRDA along with the Structural Stability Certificate obtained from the Certified Structural Engineer.

- b. The maintenance of illuminated wertisement shall also be the responsibility of the Agency. The Agency shall carry out the work pertaining to the fixing, maintaining and minoval of illuminated advertisements at its own cost. The Agency shall be wholly responsible for compensation or damages in case of samage to any property, lives of the person of Authority or public due to display of the illuminated advertisements including electric shock and fire due to short-circuit, etc. In such cases, the amount of compensation assessed by the Authority shall be final and binding on the Agency. On the expiry of contract period, the Agency shall arrange to disconnect the electric supply including pot heading of electric cable and reinstatement work etc. wherever illuminated advertisement has been displayed.
- c. The Agency shall ensure that illumination is done in such a way that it does not cause any nuisance to the vehicle drivers on the road or to the residents in the vicinity. Any objection raised in this respect shall be rectified / removed by the Agency immediately at its own cost. The use of Generators for illuminating advertisement would not be permitted under any circumstances. However, if at any time the Generator Sets are found installed for illuminating advertisement, the same would be removed at the risk and cost of the Agency without any intimation to him as stipulated in Clause No.13 appears hereinafter.

- d. It will be the Agency's sole responsibility to pay the charges, rents, taxes, electricity bills deposits on etc. levied by the Concerned Authorities directly to the authorities concerned.
- e. It shall be the sole responsibility of the Agency to obtain all necessary permissions from the Statutory Authorities required for illuminating the advertisement and obtaining power supply under intimation to the OIC.
- f. The glare factors should be so defused that it does not create any nuisance to the eyes of the road users / commuters.
- g. No Traffic light colours i.e. red, green and amber should be used for the illumination of the advertisement.
- h. If at any time it is found / noticed /or brought to notice that the Agency has drawn electric supply unauthorisely to illuminate advertisement over any Street furniture item, then the Agency shall be liable to pay on demand the electricity charges and / or penalty as computed by the Authority / Reliance Energy / MSEB or any other competent authority.
- i. The Agency shall strictly follow the provisions (amended from time to time) of the Bombay Electricity (Special Powers) Act 1946 under which at present, the use of electrical energy for the purpose of lighted (illuminated) hoardings and bill boards for more than five hours in a day is prohibited subject to such use or sonsumption shall not be permissible beyond mid-night.

5. Urgent Removal of Street Furniture item or Advertisement thereon

If any street furniture item(s) or advertisement(s) is required to be shifted or removed urgently due to accidents, act of God, thefts, or on the direction of concerned Statutory Authorities before the expiry of contract period for any other reason whatsoever, the said item or advertisement displayed on it shall be removed by the Agency with their cost forthwith within twenty four hours on receipt of telephonic / written instructions by OIC to that effect. In case of failure to do so the Authority will arrange to have the same removed at the risk & cost of the Agency. No compensation in that respect will be payable to the Agency. They shall be, however, liable to pay the charges incurred for removing/ shifting the item or advertisement. The Agency shall collect the materials from the Authority's premises within 15 days from the date of receipt of intimation to them to that effect.

6. Accident and Damage to Street Furniture item and Advertisement thereon

MMRDA shall not be responsible or liable to compensate the Agency for any theft or loss or damage, wear and tear of the Street Furniture item or advertisement on it or for non-display of advertisements due to the said damage, breakage etc, if any, for any reason whatsoever during the period of contract. MMRDA shall also not be responsible for disfigurement of or detriment to the Street Furniture item or advertisement due to pasting of paper posters or any other material thereon or due to any other reason whatsoever. The Agency shall not claim any rebate including reduction in display charges against the Authority for non-display of advertisement and removal of Street Furniture item on such account, during the contract period. The agency shall indemnify MMRDA for any litigations, claims, suits, disputes, damages etc.

7. In case of damage / accident to Street Furniture Items or the advertisement thereon; it shall be removed/ rectified by the Agency immediately from the date of intimation from the Authority to that effect. On failure of the Agency to do so in seven days or as intimated by OIC the tame would be got done by the Authority at the risk and cost of the agency.

8. Approval of advertisement matter Lab ectionable advertisement

Before the display of the advertisement, the Agency shall in the first place submit the text of advertisement matter, art work etc. of each display for the approval of the competent Authority.

The display of advertisement, designs, materials and positions for all advertisement shall be subject to the approval of the OIC.

The Agency shall not display advertisement propagating Cigarettes, Bidis or any other type of Tobacco or its product, alcohol or other intoxicant products. The Agency shall also not display advertisement related to awareness about HIV / AIDS unless permitted/approved by Public Health department, Govt of Maharashtra and screened by the MCGM in order to ensure that the advertisement does not impart an anti-women message. Similarly the Agency shall not display advertisement which imparts any message against any individual, group, class creed, religion and race.

Further, no advertisement shall be displayed which, in the opinion of the OIC offends any law or religion or public morality or is defamatory or the display whereof is prohibited by any lawful authority or is against the interest of the MMRDA.

No unsightly, indecorous or objectionable advertisement shall be displayed at any site under this contract and the decision of the competent authority as to what is unsightly, indecorous or objectionable within the meaning of this Clause shall be final and binding upon the Agency. Upon the OIC requiring the Agency to remove any such advertisement, the Agency shall forthwith remove the display thereof without any dispute / claim. No advertisement with the use of the name or pictorial representation of any national figure or emblem prohibited by law shall be displayed by the Agency. During the period of contract, if on any ground any advertisement is/are objected to by any Competent Authority or if the advertisement is objectionable in anyway as stated above, then the Agency shall remove/ deface the said advertisement within 24 hours on receipt of verbal/ written instructions to that effect. On failure of the Agency to do so, the same would be removed/ defaced by the Authority at the risk & cost of the Agency and the Agency shall not be liable for any compensation. The agency shall indemnify MMRDA for any disputes arising out of the contents, location, illumination, timings, display of advertisements displayed by him.

9. Erection of Street Furniture items: Specifications

The Street Furniture items erected by adency shall comply with all the minimum specifications mentioned in this bid.

The agency shall have to produce the manufactures warranty certificate for the items used for manufacturing of the Street Furniture items as instructed by the OIC & shall have to get the structural drawings prepared at their own cost from a licensed Structural Engineer as per site conditions & obtain structural stability certificate from him. The said structural designs have to be got certified from the Authority. The bidders shall produce evidence to conformity of all materials used for Street Furniture items to Indian standards or to International standards. After erection of Street Furniture items structural engineer shall certify the same for stability and occupation and such certificate shall be given every one year or within 1 week of the rectification of the damage done if any. The Authority shall demand any tests on the materials used and the same shall be complied by the agency at agency's cost. After submission of such Structural Stability Certificate and upon complete satisfaction of OIC, OIC shall issue NOC for operation of the Street Furniture item and display of advertisements thereon.

10. The Agency shall be permitted to display advertisements on the Street Furniture items in the space reserved for the advertisement thereon and approved by OIC. The advertisement space shall form an integral part of Street Furniture item.

11. Specifications of the Advertisement Boards

The Agency shall be responsible for the observance of the rules and regulations laid down or as may be laid down thereafter from time to time by the MCGM in this behalf and other statutory Authorities.

12. Use of Advertisement Spaces for Public Interest

The Authority reserves the right to itself to use Advt. Area of the Street Furniture items not exceeding 2% of the total advt. area for display of advertisement free of charge for whole concession period in the interest of the Authority, Municipal Corporation of Greater Mumbai, Government, Semi-Government, Central Government, Public Authority, National or Public Interest. The Agency shall make the Street Furniture from required as directed by the Authority for such display free of any advertisement on it. The Agency shall have no claim/compensation whatsoever against the Authority in this regard. The advertisement text/images would be given to the Agency for preparation of advertisement board. Composing the matter, preparation of creative, converting to any type and printing shall be responsibility of the agency. The agency shall carry out all the works stipulated in this item at his own cost at the location decided by the Authority.

13. Compliance of Contract

If the Agency shall neglect or fail to do anything which they have agreed to do under the terms and conditions of this contract, the OIC may serve a notice to the Agency asking it to do good the things agreed upon as aforesaid, and on their further neglect or failure to do so, the Authority shall have right to fine the Agency at its discretion or terminate the contract.

All the works as required to be done by the Agency under the different clauses of this contract shall be carried out by the Agency within the time specified and the manner set out and to the entire satisfaction of the said officers of the Authority. If the Agency fails to carry out the said works as aforesaid, the same shall be carried out by the Authority at its risk and cost and the Agency shall be liable and bound to pay the said charges for the same to the Authority immediately on demand at the following rates:

- i. If carried out by engaging any other agency then the cost of work carried out by the agency plus overhead charges at the rate of 10% of the total value of the work done through such agency.
- ii. If carried out by deploying departmental resources, the cost of work plus the overhead charges at the rate of 15% on the cost of labour and 20% on the cost of materials.

14. Agency's responsibility against all claims, actions, losses, etc.

- a. The Agency shall indemnify and keep indemnified MMRDA against all payment, claims, actions, demands, losses, costs, charges and expenses which the Authority may incur or be put to or which may arise by reason of the exercise of the right to erect and maintain the street furniture item or display advertisement on Authority's Street Furniture items hereby granted including claims or actions arising out of any advertisement being challenged or held to be libellous or defamatory or in consequence of the falling or displacement or breakage of apy advertisement / component of Street Furniture items or otherwise, as the case may be, or part thereof, due to any reason whatsoever and also against any claim made by the local authority or any other person respect thereof and against any claim for rates or taxes levied in respect of anything done under this contract. The Agency hereby undertake as an essential condition of this contract that they shall within 15 days of a notice in writing requiring them to do so, pay to MMRDA all more ps payable by them in respect of such claims, actions, demands, losses, costs, charges and expenses. On failure to do so the Authority shall be entitled to adjust/recover the money from the Security Deposit and the Agency shall make good the deficit so as to bring the security deposit to its original amount.
- b. If at any time during the continuance of this contract, it shall become impossible by reason of events like strike, lockout, war, fire, flood or any Government enactment or regulation or any order of the Hon'ble courts or any other cause beyond the control of the Authority, to fulfil the contract in respect of all or any site in accordance with the terms hereof, the Agency shall have no claim/damage/compensation, whatsoever against the Authority in respect of any inability or incapacity to fulfil the contract or non display of the advertisement.


However, the Agency may prematurely rescind the contract by giving (3) three months notice in writing of his intention to do so to the OIC, in case of event arising outlined in (b) above. The Agency shall have to pay the display charges during this period of notice. The said period of three months shall commence from the first day of the following month in which the notice of termination is given by the Agency. If the Agency makes the aforesaid payment without any demur or default, the Security Deposit would be returned to the Agency after expiry of six months from the date of termination of contract, subject to fulfilment of conditions stipulated in Clause No. 18(c). If however, the Agency makes any default in making the payment as aforesaid the OIC, shall forfeit the Security Deposit partly or fully as the circumstances of the case require.

15. Payment of Charges, Expenses, Municipal Licence Fees, etc.:

- Licence Fees or any other charges levied by Municipal or other Public Authorities on account of displaying accertisement on Authority's Street Furniture Items at locations mentioned under this contract including any charges for erecting structure of Street Furniture item, etc. The Agency shall, within seven days from the date of intimation by the Authority, pay to the Authority or any concerned Authority rents, taxes, charges, Licence Fees, which are required to be paid by the Agency. The Street Furniture items shall be the property erected for benefiting public. The Authority shall in no way be responsible for the above payment. Any additional expenses or charges by way of penalty, interest/penal interest etc. in case of failure to pay shall be borne by the Agency.
- b. The Agency shall produce for verification of the OIC the original receipts in respect of the payment of Municipal Licence Fees and other rents and taxes levied by such Competent Authorities, whenever called upon to do so. The Agency shall produce the receipts in respect of the payment of Licence fees and other rents deposits etc. to the Authority every six months along with a photocopy for the Authority's record.
- c. If any such sum due remains unpaid by the Agency and the Authority is called upon by the concerned Authorities to make good the payment then the OIC, would be at liberty to make the payment from the security deposit of the Agency or any other amount from any other contract of the Agency available with the Authority/other Statutory Agency.

16. Payment of Display Charges & mode of payment

a. The Agency shall pay to the Authority the display charges quoted by it in the 'Form of Financial Offer' by way of monthly instalment in advance by demand draft / pay order in favour of 'MMRD FUND' payable in Mumbai. The first instalment shall be paid on the last day of the construction period (i.e. 365th day) and the subsequent instalments shall be paid as advance on the same date of each month. The Total display charges divided by the days for which display will be done will yield display charges per day. Amount of annual instalment will be worked out by the multiplying the charges per day with no. of days in a year. And amount of annual instalment divided by the month in a year will yield the amount of monthly instalment payable by the agency. The amount of instalment will be worked out at above rates and communicated to be paid in advance.



<u>Note</u>: The display charges, No. of display days, amount of Instalments may vary as per actuals/work order. Based on the financial offer pro-rata display charges instalment will be calculated for completed work by the OIC and it will be binding on the bidder.

The Agency shall be required to pay to the Authority interest at 15% per annum on the balance amount for the period from the due date of payment as aforesaid, till the date, payment is actually received (both days inclusive) by the Authority. In case the payment is withheld beyond period of thirty days from the due date of payment, the Authority shall be at liberty to recover the due amount from security deposit or terminate the contract without any claim for compensation/refund by the Agency under provision of Clause No. 22. In case, the display days are reduced due to delay of

agency in completing of Street Furniture items' construction, MMRDA shall not be responsible for loss of revenue and instalment will not be reduced. But in case of reasons beyond control of Authority, the display could not commence, then the amount of instalment will be reduced proportioned to the days reduced or display days could be added as per the discretion of OIC.

b. The Agency shall construct all the Street Furniture items and then apply for permission for display. If agency fails to construct Street Furniture items in the stipulated time, reasons shall be given and if they feel not satisfactory, the contract shall be terminated and no compensation will be paid to the agency and EMD and Security Deposit will be forfeited and the property constructed shall belongs to Authority.

c. Addition of Street Furniture Items

MMRDA reserves the right to increase the quantity of any of the street furniture items mentioned in Annexure 'A'. The agency shall not claim any compensation, if quantity of items in Annexure 'A' increases or decreases by 10% for each type. In case, the quantity increases beyond 10% Metropolitan Commissioner, MMRDA at its sole discretion may decide any form of compensation in terms of pro- rata display period/ pro- rata payment as may be deemed fit.

17. Insolvency of the Agency or non-observance of the obligation of contract on the part of Agency

If the Agency shall commit any act of insolvency or shall be adjudged insolvent or shall have an order for compulsory winding up made against them or pass an effective resolution for winding up voluntarily or subject to the supervision of the court or if the Agency shall suffer execution to be issued or shall suffer any payment under this contract to be attached or shall charge or encumber this contract or any payment due or which may become due to the Authority hereunder or compound with their creditors or if the Agency fail to observe and perform any of the obligations, covenants or agreements on their part herein contained or if the Agency shall go into liquidation, then on all or of such events happening, it shall be lawful for the OIC, to terminate this contract and take possession of Street Furniture Items & advertisements along with its frame work, if any, displayed under this contract and the same shall become the property of the Authority without prejudice to the rights of the OIC, to recover all

sums then due by way of rentals or consideration under this contract and damages, if any, in respect of any breach or default on the part of the Agency.

18. Payment of Security Deposit

- a. As security for the due fulfilment of the terms of this contract, the Agency shall deposit, with the Authority within **45 days** from the letter of acceptance (work order) from the Authority, an amount equal to 10% of the premium fee offered in 'Form of Financial Offer' (P.F) for whole concession period. The Agency shall deposit the amount of Security Deposit in the form of Bank Guarantee; which shall be required to be renewed every year before expiry. On failure of the Agency to submit the Security Deposit within the due date, penal interest @ 15% p.a. will be charged till the amount of Security Deposit is furnished by the Agency (both days inclusive). If the Agency further fails to deposit the amount of Security Deposit along with interest within Fifteen days after the expiry of due date, the contract awarded to the Agency shall stand terminated without issue of any further notice. However, the balance if any shall be paid as prescribed within time limit specified.
- b. In case the Agency is in arrears of any payments, the OIC shall give a notice of 15 days in writing to recover such amount. At the expiry of the notice, without any further consent on the part of the Agency, other than the consent which is implied by the execution of the agreement, to use/realise the said Security Deposit or any part thereof and to apply the proceeds of such realisation in or towards the payment and satisfaction of any and every sum which may be due by the Agency to the Authority or the Municipal Corporation of Mumbai, Mumbai Metropolitan Region Development Authority or any other Statutory Authority under this contract. If the Agency fails to honour any contractual obligation or defaults in making payment for any reason, then the Authority will be at liberty to recover the said cost from the Security Deposit or any other amount due and payable to the Agency. In such an event, the Agency shall make good the amount of Security Deposit to its original amount within Fifteen days of intimation by OIC to make good the amount, failing which the Authority would be at liberty to take such action as provided herein, including termination of contract.

c. Refund of Security Deposit

 The entire amount against Security Deposit shall be refunded only after complying with all the Conditions of the Bid under consideration, within 6 months after completion of concession period and after adjusting against all incurred expenditure by MMRDA for doing good the damages made by agency.

ii. The Agency shall also produce all the documentary evidence as may be required by the Authority so as to ensure that it has paid all dues to the MCGM and other Statutory Authorities for the individual site. (No Dues Certificate).

d. Forfeiture of Security Deposit

In the event the Agency commits a breach of any of the terms and conditions of the contract or fails to observe and comply with any of the requirements or arrears of any payment which is due for more than 30 days from issue of notice under this contract, the OIC, shall be entitled to forfeit the Security Deposit either in whole or in part thereof at his discretion without prejudice to other rights and remedies open to the Authority and it shall be binding on the Agency.

19. Non payment of charges

Any sum due and payable by the Agency the Authority under this contract, if not paid within the prescribed time limit shall be payable with 15% interest per annum (both days inclusive) irrespective of the fact whether the said condition is mentioned hereinabove or not.

20. Transfer of right

The Agency shall not assign, under-let, sub-let the contract or assign or transfer in any way the right granted under this contract to any person or persons or firm or Agency or Company without prior approval of the Authority. Also, the Agency shall not mortgage or rent-out any of the street furniture item during the concession period except Kiosks. Title of the land under any of the street furniture items shall not be transferable and at all the times shall be property of MMRDA.

21. Transfer of the Street Furniture items on the expiry / termination of the contract

Street Furniture items will be property of the Authority for the entire concession period and display of Advertisement will be prohibited after the expiry / termination of the contract.

The Agency shall remove all the advertisement boards on the Street Furniture items, if any displayed thereon, within 7 days from the last day of expiry /

termination of the contract. Also the agency shall handover all the street furniture items to Authority in good, workable conditions within 15 days from date of expiry/termination of contract. The agency shall make good all the defects within these 15 days before transfer to MMRDA.

On failure of the Agency to remove the advertisement within stipulated time, said advertisements shall be removed by the Authority at the risk and cost of the Agency and the agency shall be liable to pay the penalty of Rs. 5000/- per street furniture item/day to Authority till that item not get removed or as actual whichever is higher. On failure of agency to handover the street furniture items in good conditions, Authority shall make good the street furniture items at the cost and risk of Agency upto entire satisfaction of OIC. The required costs for both the events above shall be recovered from security deposit of the agency.

Due care shall be taken by the Agency while booking the contracts for advertisements on Street Furniture Items so that no advertisement is displayed after the expiry of this contract. These cost are based on 2012 prices and will be adjusted by the OIC on the actual year of levying during the concession period.

22. Termination of Contract

If, during the period of contract, the OIC has reasons to be dissatisfied with the execution of contract and/or the performance of the Agency, the OIC may by notice in writing call to the Agency to remove the cause of such dissatisfaction in the way to be indicated in the notice and if the Agency fail for a period of 15 days after the receipt of such notice to remedy such cause of dissatisfaction to the satisfaction of the OIC then the OIC or the officer appointed by him shall serve a further 7 days notice to the Agency in writing and on failure of the Agency to follow the orders in the said notice and notwithstanding anything contained in the agreement to the contrary, the OIC shall have a right to terminate the contract by giving a final 7 days Notice in writing and the contract shall on expiry at the notice period stand terminated without prejudice to the right of the OIC to forfeit the Security Deposit as provided under clause 18(iv) of this contract. In addition to the Security Deposit the OIC shall have right to forfeit any other amount due and payable by the Agency under this or any other contract with the Authority. On termination of the contract the Agency shall also be liable to pay all sums including an amount equal to 25% of display charges for balance period payable to the Authority as on the date of termination of contract. This shall be in addition to the forfeiture of 'Security Deposit' as provided under Clause no. 18 of the 'Conditions of Contract'. Also, the street furniture items shall be the property of Authority.

23. Jurisdiction of Court

The court located in Mumbai only shall have jurisdiction to try and decide the matter/dispute between the parties.

24. The Contract Agreement

The Agency whose bid has been accepted shall within one month from the date of acceptance letter (work order) enter into a written agreement with the Authority for the proper fulfilment of the contract on lines similar to the terms provided herein, failing which it shall be construed as if the Agency has entered into binding agreement with the Authority in terms of Clause No. 12 of the 'Instructions to Bidders'. The Agency shall also get the contract Agreement duly adjudicated upon from the stamp office at Mumbai.

In the event of the bid of a Partnership Firm/ company being accepted, the contract agreement shall be signed by all the partners of the Firm/ Company or by the competent persons on behalf the Firm/ Company, subject to production of the necessary resolution or any other documents in support thereof. The form of draft Agreement's enclosed in Annexure 'C'.

25. Preparation of the Agreement

The Agreement shall be prepared and engrossed by the Authority and shall be forwarded to the Agency after the acceptance of its bid. Should the Agency not execute the Agreement after the date of its receipt by them as stated above, the Authority may, at its option and without prejudice to its other rights or claims against the Agency for non-compliance with any of the provisions of these conditions, within thirty days after the receipt of the Agreement by the Agency, by notice in writing to the Agency, revoke the acceptance of the bid and thereupon the Authority shall not be liable for any claim or demand from the Agency in respect of any matter or thing whatsoever in connection with the contract, but the Authority shall be entitled to the forfeiture of the Earnest Money deposited by the Agency alongwith the bid or the Security Deposit paid by the Agency on the intimation of acceptance of this bid.

26. Stamp Duty

The stamp duty shall be borne by the Agency and an amount of Rs.100/- being the cost of preparation of the Agreement in duplicate shall be paid by the Agency within seven days from the date of acceptance letter.

- 27. The Agency shall comply with the provision of ESI Act, 1948, amended from time to time and shall pay the contribution (employees and employers) in respect of labourers employed by Agency such contribution shall be paid through the Authority's ESI Department. It shall be obligatory on the part of the Agency to pay, if any liability arises at the time of ESI Inspection.
 - a. It shall be obligatory on part of the Agency to submit the declaration forms Nos. 1 and 3 in accordance with regulation 11 read with regulation 14 of the above mentioned Act within 3 days from the date of commencement of the work to the ESI Section/Dept. of the Authority duly certified by the Head of the Department. No payment shall be released to the Agency till the compliance of said formalities.
 - b. The Agency shall also submit Attendance and Wage Register of all labourers engaged on work (employees covered under ESI or beyond ESI) every month on or before 10th day of the next month for on going works to the Authority's ESI Section/Dept. duly certified by the Department concerned and representative of Audit Department. The amount to be paid towards ESI contribution will be intimated to the Apency by the ESI Section/Dept. within 3 working days from the date of submission of Attendance/Wage Register.
 - For those works which are to be completed in short duration i.e. one month or less than one month, the Agency shall submit Attendance and Wage Register, immediately on completion of work and payment of Wages to the labourers, duly certified by the Department concerned and representative of Audit Department. The Agency will also comply with the requirement as stated in para (ii) above.
 - c. In the event of failure of comply with the above requirement, the Agency shall be liable to pay penalty comprising of penal interest presently at 12% p.a. as per Regulation 31A and damages as per Regulation 31C depending upon the period of delay in payment of usual ESI contribution and the same will be paid to ESI Contribution under separate challan. No dispute on this account will be entertained. The decision of OIC in this regard shall be final.
 - d. In case the ESI covered employees of the Agency continue working and drawing wages within insurable wage ceiling beyond 30th September and 31st March, the information in respect of these employees such as name of the employee, his insurance number and the name and code number of the ESI

Panel Doctor with whom he has registered his name shall be furnished to the ESI Section on 10th Day of the following months.

28. The Agency shall make its own arrangement for Drinking Water/other water and Electricity required for the project. The water and/or sewerage charges wherever applicable shall be paid to the appropriate Authority directly at its cost and should submit receipts thereof to the Authority.

29. Removal of Debris

The Agency shall remove the debris from the site of work within 24 Hrs. from the date of written instructions to the Agency to that effect, failing which the Authority will remove the same by engaging any other agency or departmentally and the cost of the same shall be recovered as stipulated in the Condition No. 13 of the 'Conditions of Contract' from any money due to them, such decision shall not form the subject matter of any dispute.

30. Safety Measures

The work shall be carried out without causing any inconvenience to the pedestrians, shop owners, etc., in the vicinity. The Agency shall further take all necessary precautions such as display boards, signals, barricading of sites, posting of watchmen etc., before starting the work and all expenses on this account shall be borne by the Agency. The Agency shall not cut / prune the branches of the tree in the scinity of the Street Furniture Items without prior written permission of the Supdt. of Garden Department / Tree Authority of the MCGM. The necessary permission shall be obtained by the Agency at its cost.

- 31. All reinstatement work shall be done by the Agency so as to match with the surrounding surfaces at their own cost, to the satisfaction of the OIC.
- 32. The Agency's attention is drawn to the Contract Labour (Regulation and Abolition) Act, 1970 and the Maharashtra Contract Labour (Regulation and Abolition) Rules, 1971. The Agency shall comply with the provisions of the said Act and Rules framed there under.
- 33. Before submitting the bid, the Bidder if so desired may inspect the sites of Street Furniture Items and then quote his offer accordingly. The location can slightly vary depending upon the site conditions and the location before erection shall be got marked from OIC by the Agency.
- 34. If any damage is caused to the surrounding property while carrying out the work by the Agency, the same shall be made good free of cost.

35. Illegal Gratification

Any bribe, commission, gift or advantage given, promised or offered by or on behalf of the Agency, agent or servant of any one on their behalf of any officer, or employee of the Authority or to any person on their behalf in relation to the obtaining or the execution of this or any other Contract with the Authority shall, in addition to any criminal liability which they may incur, subject the Agency to the recession of the contract and all other contracts with the Authority and to the payment of any loss or damage resulting from such recession, and the Authority shall be entitled to deduct the amount so payable from any monies due to the Agency under the contract or any other contract with the Authority. The Agency shall not lend or borrow from or have to enter into any monetary dealings or transactions either directly or indirectly with any employee of the Authority and if they shall do so the Authority shall be entitled forthwith to rescind the contract and all other contracts with the Authority. The OIC shall settle any question of dispute as or to the commission of any offence or compensation payable to the Authority under his clause in such a manner as he shall consider fit and sufficient and his consider final and conclusive.

36. Termination of contract for death

If the Agency is an individual or apprietary concern and the individual or the Proprietor dies and if the Agency is a partnership concern and one of partners die then <u>unless</u> the OIC is satisfied that the legal representative of the individual or the proprietor of the proprietary concern and in the case of partnership, the surviving partners, are capable of carrying out and completing the contract, the OIC shall be entitled to cancel the contract as to its incomplete part without the Authority being in any way liable for payment of any compensations to the estate of the Agency and/or to the surviving partners of the Agency on account of the cancellation of the contract. The decision of the OIC, that the legal representative of the Agency or the surviving partners of the Agency cannot carry out and complete the contract shall be final and binding on the parties. In the event of such cancellation the Authority shall have discretion to hold / not hold the estate of the Agency and/or the surviving partners of the Agency liable in damages for not completing the contract.

37. The OIC may from time to time delegate his powers to any officer of the Authority for execution of contract and all the decisions, orders issued by the said officer shall be binding on the Agency. If any doubt, dispute or difference arises or happens between the Officer on the one hand and the Agency on the

other hand in respect of the said works or any of them or relating to the quantities, qualities, workmanship, description or manner of work done and executed by the Agency or to be quantity or quality of the materials to be employed therein or in respect of any additions, deductions, alterations or deviations made into or from the said works or any part thereof or of any plans, drawings, conditions, recoveries or of any instructions, orders, directions referred to therein or which may be furnished or given during the progress of the works or in respect of any certificate of payment, order which have been made or in any way whatsoever relating to the interest of the Authority or of the Agency in the premises, every such doubt dispute and difference shall within 14 days of the occurrence of the doubt, dispute, difference be referred to the Metropolitan Commissioner, MMRDA who shall give his decision within a period of 90 days. The decision of the Metropolitan Commissioner, MMRDA shall be final and binding on the Agency.

- 38. Subject as otherwise provided in this contract all notices to be given on behalf of Authority and all other actions to be taken on its behalf may be given or taken by the OIC. All notices, communications, references and complaints made by the Authority or the Officer's representative or the Agency inter-se concerning the work shall be in writing and no notice communication, reference or complaint not in writing shall be recognised, and if sent by registered post and under certificate of posting to the last known place or abode or business of the Agency shall be defined to have been served on the date when in the ordinary course of post these would have been served on or delivered to him.
- 39. Notice from the Agency to the Authority shall be served to the OIC personally or by registered post addressed to the Authority at their office address of Mumbai Metropolitan Region Development Authority (MMRDA), Bandra-Kurla Complex, Bandra (East), Mumbai-400 051.
- 40 .i. The Agency shall comply with the Policy Guidelines of Grant of Permission for display of Sky signs and advertisement under section 328 and 328A of MMC Act 1888.
- 40 .ii.The Agency shall also comply with section 116(4) of Motor Vehicles Act 1988 while displaying advertisement.

41. Rounding off amounts

The total amount due towards Display Charges shall be rounded off to the nearest rupee. An amount of 50 paise and below shall be ignored and 51 paise and above shall be reckoned as one rupee.

42. Penal Action

- a. If the Bidder after submitting the BID withdraws or varies it within the validity period the Bidder shall be liable to be banned for bid participation future from the Authority for a period of **Five years** that shall be reckoned from the date of withdrawing or varying the bid.
- b. The Agency after award of contract shall perform the contract with due diligence of the 'Conditions of Contract' put to bid, failing which it shall be construed upon as the Agency has defaulted in honouring contractual obligations and the defaulting Agency after termination of contract shall thus be liable for penal action so as to debar the defaulting Agency from having dealing with the Authority either permanently or for the period as shall be decided by the Authority.

The penal action shall be without prejudice to the rights and remedies available to the Authority and also be in addition to the action to be instituted against the defaulting Agency under other terms and conditions of the contract.

43. Precaution during monsoon: The Agency shall ensure that no water stagnation takes place near the Street Furniture items and shall carry out such measures as directed by OIC from time to time at his cost. The site shall not create any damage to pedestrian/traffic flow atc. Any accidents/claims out of it etc. shall be the responsibility of the agent.

44. Conflict of interest

The BKC area of E, G and Gn blocks for which the bids have been invited will have street furniture items as detailed in this bid. Erection of any advertisements or hoardings or any street furniture items in the same area by other agency shall directly conflict with the sustainability of the successful bidder. Therefore, this shall not be allowed. However, if in emergency, MMRDA decides to erect the same; it shall not be considered as conflict of interest.

If MMRDA decides to erect any other street furniture item(s) mentioned in Annexure A with or without advt. in BKC, the right of first refusal shall be given to successful bidder of this bid to avoid any conflicts/litigation and payment of premium, display period, etc. shall be decided by Metropolitan Commissioner, MMRDA..

45. Early termination of contract by Agency

In case, the agency terminates/withdraw/cancels the contract on his will before expiry of concession period, the street furniture items shall be the property of

MMRDA and no rights, howsoever, shall be established by the agency and security deposit shall be forfeited by MMRDA.

46. Insurance

<u>Insurance during the Construction Period:</u> The agency shall, at its cost and expense, purchase and maintain during the Construction Period such insurances as are necessary, including but not limited to the following:

- i. builders' all risk insurance;
- ii. workmen's compensation insurance;
- iii. third party insurances;

any other insurance that may be necessary to protect the agency, its employees and its assets (against loss, damage or destruction, at replacement value) including all Force Majeure Events that are insurable and not otherwise covered in items (i) to (iii).

Insurance during the Operations Period The agency shall, at its cost and expense, purchase and maintain during the Operations Period insurance to cover against:

- i. loss, damage or destruction of the Project Facility, at replacement value;
- ii. the agency's general (ligbility arising out of the Concession;
- iii. liability to third parties; and

any other insurance that may be necessary to protect the agency and its employees, including all Force Majeure Events that are insurable and not otherwise covered in items (i) to (iii).

The agency shall, from time to time, provide to MMRDA copies of all Insurance Policies (or appropriate endorsements, certifications or other satisfactory evidence of insurance) obtained by the agency in accordance with this bid.

- 47. MMRDA reserves the right to amend any of the conditions in contract in larger public interest and the same shall be binding on the agency without any cost to MMRDA.
