- 2.0 A pre-bid meeting will be held on 21/05/2013 at 15.30 Hrs at the office of the Chief, T&C Division.
- 3.0 The bid will be received upto 13.00 Hrs on 05/06/2013 and will be opened by The Chief, T & C on same day at 15.30 Hrs, if possible.
- 4.0 Bid will not be sent or received by Post.
- 5.0.To qualify for award of the contract, each bidder in its name should have satisfactorily completed following in the last five years i.e. 2007-08 to 2011-12:
 - a. Achieved in atleast two continuous financial years, a minimum annual financial turnover (in all classes of Civil Engineering construction work only) of not less than estimated cost put to tender.
 - b. One Civil Engineering construction work (like Flyovers/Bridges/FOBs/Skywalks, etc) of aggregate value not less than 80% of estimated cost put to tender.
 - c. Executed in any one year, the Structural steel fabrication & erection work of minimum 50 % quantity as mentioned in the tender.
- 6.0 Planning of the structure, Design of the structure from Licensed Structural Designer, proof checking from IIT Mumbai & approval from Railway/MCGM departments shall be the responsibility of bidder
- 7.0 No Joint Ventures shall be allowed.
