The Bid Document forms for the above work shall be issued during working days from 15/05/2013 to 28/05/2013 between 11.00 Hrs. to 16.00 Hrs. at the office of the Executive Engineer (Wadala Truck Terminal), 1st Floor, Unit No..115, A-1 Building, Wadala Truck Terminal, Wadala (East), Mumbai- 400 037, on payment of Rs.10,000/- (Nonrefundable) in the form of Pay order/Demand Draft in favour of MMRD Fund of Nationalized or Scheduled Bank and on production of attested copies (along with originals for verification) of valid registration certificate, Income tax certificate and works contract tax No. / Certificate.
2. A pre-bid Meeting will be held on 21/05/2013 at 15.00 hrs at the office of Chief T & C Division.
3. The sealed tenders will be received upto 13.00 Hrs on 05/06/2013 and will be opened by The Chief, T & C on same day at 15.00 Hrs, if possible.
4. Tender will not be sent or received by Post.
5. To qualify for award of the contract, each bidder in its name should have satisfactorily completed following in the last five years i.e. 2008-09 to 2012-13:
 - a. Achieved in atleast two continuous financial year, a minimum annual financial turnover of not less than Rs. 19 Crores in all classes of Civil Engineering building construction work.
 - b. One work of sewage treatment plant based on the compact/energy efficient, low sound RMBR/Rotating Biodisc Contactor/ECOBIOPACK technology of capacity not less than 4.5 MLD for any State / Central Government Department / Undertaking.
 - c. Bidder shall have experience of operation & maintenance of same technology sewage treatment plant for the period not less than 30 months.
6. Work shall be carried out as per the approval / guide lines of MCGM and all types of clearances / permissions from any State / Central Government Department / Undertaking required for construction of STP shall be obtained by the bidder.
7. Joint Ventures shall be allowed only between two parties i.e. one each for construction of civil work & for Erection/Commissioning/Operation/Maintenance of STP. Technology providers of STP may form Joint Ventures with one or more bidders of civil work.
8. The offer shall remain valid for a period of 120 days from the date of submission of tender.
