    - Bids shall remain valid for period of 180 days from the date of submission of bid.
    - Right to reject any or all bid(s) without assigning any reason thereof is reserved with MMRDA
    - The bids shall be opened on the same day at 16.00 hrs, if possible.
    - All payment towards Bid Cost / Bid Security shall be paid in the form of Pay Order/ Demand Draft of Nationalized / Scheduled Bank payable at Mumbai in favour of 'MMRD Fund'.
    - Bid documents will not be delivered or received by post/courier.
    - Bids received late will be rejected.

  - ELIGIBILITY:**
    - For award of work, the bidder should have achieved, in last five years ending 31<sup>st</sup> March, 2013 a minimum annual financial turnover (in all classes of Civil Engineer Construction Work of not less than 368 Crores.
    - The bidder should have successfully completed One Flyover/Viaduct / bridge in urban area using precast segmental construction work costing at least Rs. 390 Crores in the last 5 years having area not less than 60,000 sq meter.
