1. The consultant submitting the quotation must be having valid accreditation from QCI/NABET (Accreditation Certificate to be attached with the quotation).
2. Agency applying for the said work must be having minimum 3 prior similar works (obtaining CRZ Clearance & preparation of EIA). Attach proofs of the same.
3. The above amount will be inclusive of related permissions from all concerned departments and all taxes, other overheads, travelling cost etc.
4. The consultant should quote the rate inclusive of GST & other all Taxes, Cess and Duties etc.
5. No Advances and escalation shall be applicable for the work and payment will be done after submission of mentioned documents subjected to statutory deduction of taxes, TDS etc. as applicable.
6. The CRZ application along with DPR EIA must be submitted in the one month from the date of issue of LOA with a copy to MMRDA (Hard and soft copy). The draft EIA report must be submitted in hard copies (2 copies) as well as in soft copy (in DVD & Pen drive) by 5th Month.
7. The Completion period of the work is 1 year. The consultant shall submit the draft EIA report in 5 months.
8. The payment schedule is as mentioned below:
 - Submission of CRZ Application to MCZMA – 10 %
 - After obtaining CRZ clearance – 30 %
 - Submission of Draft EIA Report – 30 %
 - Acceptance and disclosure of final EIA report by funding agency-30%
